

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.jenshappymail.com> and Jen's Happy Mail LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jen's Happy Mail LLC include <https://www.jenshappymail.com>. The Jen's Happy Mail LLC website is a ecommerce site. By using the Jen's Happy Mail LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Jen's Happy Mail LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Jen's Happy Mail LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sharing Information with Third Parties
